#### **Summary Paragraph**

The Edgewater Glen Historic District is located within the larger community of Edgewater on Chicago's North Side, approximately seven miles from the city's primary business district, known as the Loop. The district is roughly bounded by W. Hood Avenue on the north, W. Norwood Street on the south, Broadway on the east, and Clark Street on the west. The district is intersected by two north-south streets: Glenwood Avenue and Greenview Avenue. Glenwood divides the 1300 and 1400 blocks and Greenview divides the 1400 and 1500 blocks. The 1200 and 1300 addresses run continuously on blocks that are the equivalent of two city blocks in length. The following areas are encompassed:

• W. Hood Avenue: 1200 block (south side), 1300, 1400, 1500 blocks

W. Glenlake Avenue: 1200, 1300, 1400, 1500 blocks
W. Norwood Street: 1200, 1300, 1400, 1500 blocks

The district is comprised of a total of 422 buildings, including 411 contributing buildings and 11 non-contributing buildings. The 411 contributing buildings include 349 primary residential buildings and 62 contributing garages. Residential buildings consist of 291 single-family houses and 58 multi-family apartment buildings. Nearly all the single-family houses feature either the American Foursquare subtype of the Prairie style (157) or a vernacular version of the Queen Anne style (107). Multi-family buildings are mainly clustered near the east end of the district, with concentrations on the 1300 block of Hood Avenue, the 1200 block of Glenlake Avenue, and the 1300 block of Norwood Street. They include two-flats (40), three-flats (5), one four-flat, six-flats (4), and 8 apartment buildings with over six units. Although a variety of architects and builders contributed to the design and construction of the district, it maintained a uniform scale and cohesiveness throughout its period of significance, which starts in 1890 and ends in 1928, the year it reached residential maturity, as evidenced by the 1928 Sanborn Fire Insurance Map.

#### **Narrative Description**

Edgewater Glen is a distinct, suburban-style island of single-family houses within Edgewater, a sprawling, densely built community area bounded by Lake Michigan and Ravenswood Avenue from east to west, and Devon and Foster Avenues from north to south. The housing stock within Edgewater features a high percentage of multi-family buildings that includes two-flats, three-flats, six-flats, common-corridor buildings, courtyard buildings, and high-rise apartment buildings near the lakefront. An exception is Lakewood Balmoral, another suburban style neighborhood, which is located at the southeast corner of the Edgewater community area and was designated a NRHP district in 1997 under Criterion A for community planning and development. Edgewater has two other designated NRHP districts, both of which are also in the south half of the community: the Bryn Mawr Avenue Historic District (listed 1995) and the Andersonville Commercial Historic District (listed 2010).

The Edgewater Glen Historic District is situated at the north periphery of the larger Edgewater community. The neighborhood has a decidedly suburban style ambiance as 291 of its 349 residential

buildings are detached, single family houses placed upon wide lots with uniform setbacks on streetscapes featuring grassy parkways with an abundance of trees. Residential parcels in the district are approximately 33 feet in width in comparison to the standard 25-foot-wide Chicago lot and are 125 feet deep. Lots have back yards and most houses—though not all—have garages that open onto alleys. Corner buildings typically have garages that open onto the street. Hood and Glenlake Avenues are both one-way streets. The quiet, tree-lined neighborhood remains largely insulated from heavy traffic, in contrast to Broadway and Clark Street to the east and west, respectively, which are busy commercial thoroughfares with traffic lights.

Housing in the district is remarkably cohesive in terms of building types, period of construction, style, scale, rooflines, and materials. Most of its residential buildings were erected within a fifteen-year timeframe—1900 to 1915—and dozens were either designed or built by the same architect of contractor, respectively. For example, architect Edward Benson designed a total of 41 houses in the district that are similar in appearance, 35 of which are located on the 1400 and 1500 blocks of Norwood Street. Likewise, contractor Roy Knauer built 31 houses in the district, 26 of which are on the 1200 and 1300 blocks of Glenlake Avenue. Thus, the cohesive housing stock on these blocks was in large part controlled by these individuals and helped define the character of the district.

Nearly all the district's contributing single family houses—264 out of 291—were designed in vernacular versions of either the Prairie style of architecture, including its boxy, American Foursquare subtype, or the Queen Anne style. And in fact, many of the American Foursquare and Queen Anne style houses are strongly similarity in appearance, differing only in their rooflines. Full-façade porches—both open and enclosed—are a defining feature of the district's single-family houses in both styles, as is their steeply pitched hip and gabled rooflines (IMAGES 1-7). (See Essay titled, "Architectural Styles in the District" in Section 8 for a detailed description of the district's vernacular Prairie and Queen Anne style houses.)

Twenty-one of the district's remaining houses feature other styles/forms that were popular in the early twentieth century, including the Craftsman (11), Chicago Bungalow (4), Dutch Colonial (4), Colonial Revival (1), and Italian Renaissance Revival (1) (IMAGES 8-10). Six houses exhibit no discernible style. Houses in the district are generally 1 ½ to 2 ½ stories in height, while multi-family buildings range from two to four stories in height.

Multi-family buildings in the district have flat roofs and nearly all (53 of 58) are sheathed in brick, while the remaining five buildings of this type are sheathed in greystone. Stone is also used for window lintels and sills, copings, and decorative accents. Forty of the multi-story buildings are two-flats, many of which have three-sided, full-height window bays and partial width porches (IMAGE 12). Multi-family buildings feature a variety of stylistic detailing, including Classical Revival and Tudor Revival (IMAGES 11 and 14). Two of the district's most expansive apartment buildings—three feet in height with a dozen units apiece— are across the street from each other, anchoring the northeast and northwest corners of Glenlake and Glenwood Avenues, with the building at 6103-02 N. Glenwood exhibiting Prairie style detailing (IMAGE 13).

The district's residential buildings are primarily sheathed in traditional materials—brick (106), stucco (68), wood clapboard (47), and greystone (5)—while 84 of the houses originally sheathed in wood have been reclad in vinyl siding, and 37 houses are sheathed in a combination of materials. Fenestration throughout the district is mainly comprised of double-hung or casement windows. The upper sashes of double-hung windows on many of the buildings are subdivided into multiple lights by wood muntins.

Many of the single casements adjacent to the front doors have leaded glass or decorative diamond patterns. Enclosed porches typically feature windows arranged in horizontal strips. The use of three-sided projecting bays is a common design feature.

The district is remarkably intact and includes only six buildings erected post-1928. Its buildings generally retain very good architectural integrity. Common alterations include the installation of replacement windows, although in these cases the fenestration patterns generally remain unchanged. Some porches have been altered or enclosed, and some original front doors have been replaced. A few houses have received non-original dormers. Queen Anne houses in Edgewater Glen were originally sheathed in wood clapboard, which has been covered over/replaced by vinyl siding in many cases. The installation of vinyl siding is typically sympathetic in appearance to wood siding and in most cases does not detract from the building's overall historic design.

In addition to the 349 primary contributing residential buildings, the district has 62 contributing garages built within the period of significance. Contributing garages vary in size and accommodate one, two, or three cars. They have walls sheathed in brick, stucco, or wood clapboard that in many cases match the contributing residential building to which they belong. Many of the contributing garages retain their original wood-paneled service doors and wood windows; however, original garage doors have generally been replaced with metal overhead doors. Brick garages have flat roofs while stucco- and wood-clad garages typically have hip or gable roofs (IMAGES 15-17).

The 11 non-contributing buildings in the district were identified as such if they experienced extensive alterations that resulted in a loss of architectural integrity or were built outside the period of significance. Examples of non-contributing buildings include a Ranch type house from the 1960s at 1542 W. Glenlake (IMAGE 18) and a house with a heavily altered front façade at 1245 W. Norwood Street (IMAGE 19).

#### **Complete Inventory for the Edgewater Glen Historic District**

Construction dates on the table that follows were identified from either Chicago building permits, the building permit columns of *The Economist* or *American Contractor*, and/or from a review of the Edgewater Historical Society House Tour Booklets. When such dates were not identified through a review of these sources, circa construction dates were obtained by a review of Sanborn Fire Insurance Maps from 1905, 1928, and 1950.

The Edgewater Glen Historic District is a visually distinct residential neighborhood comprised mainly of detached, single-family houses, which is located within the larger community area of Edgewater on Chicago's North Side. The neighborhood—roughly bounded by Broadway and Clark Street, from east to west, and by W. Hood Avenue and W. Norwood Street, from north to south—is comprised of six subdivisions that were created between 1890 and 1904 and was largely developed between 1900 and 1915.

The name Edgewater Glen was created in the early 1970s when residents were forming a neighborhood association and needed a name for their organization that reflected the neighborhood. Glen was chosen because it was the first syllable of two intersecting streets in the neighborhood – Glenlake and Glenwood.

The district is comprised of a total of 411 contributing buildings, which include 349 primary residential buildings and 62 contributing garages. The residential buildings include 291 detached, single-family houses and 58 multi-family apartment buildings, most of which are two-flats. The period of significance for the district is 1890 to 1928, the years in which it was developed and reached residential maturity.

The Edgewater Glen District warrants consideration as a NRHP District under Criterion C for Architecture. The district's 291 contributing houses constitute a remarkably cohesive ensemble of detached, single-family dwellings, 263 of which comprise vernacular versions of the Prairie style—including the boxy, American Foursquare subtype of this style—and the Queen Anne style. In addition to uniformity of style, houses and multi-family buildings throughout the district share similar setbacks, massing, height, rooflines, and materials. The district has sufficient integrity for listing on the NRHP.

## Edgewater and the Subdivision and Development of Edgewater Glen

The Edgewater Glen District is located on the north periphery of Edgewater, a lakefront community located about seven miles north the Chicago's Loop. Edgewater is bounded by Lake Michigan and Ravenswood Avenue from east to west, and Devon and Foster Avenues from north to south.

Once of the earliest settlers in the Edgewater area was a Luxembourger named Nicholas Kransz. In 1848, he constructed the first building in the area, a frame homestead on the northeast corner of present-day Ridge Avenue and Clark Street. It was called the Seven Mile House based on its distance from Chicago's City Hall. The Kransz farmstead extended to include what is now the western half of the Edgewater Glen District, the area from Clark Street to Glenwood Avenue, between Hood Avenue and Norwood Street.<sup>2</sup>

The subdivision and platting of the larger Edgewater community began in the late 1880s. The name "Edgewater" was given by the developer John Lewis Cochran to the first subdivision that he purchased in the southeast portion of the area in 1885. It was bounded by present-day Broadway, Bryn Mawr, Lake Michigan

and Foster Avenue. Residents of this period were mainly German, Scandinavian and Irish. In 1889, Edgewater was annexed by the City of Chicago.<sup>3</sup>

Subdivision of the Edgewater Glen District began in its eastern half, the area between Glenwood Avenue and Broadway, in the 1890s. The first and second subdivisions (in order of their recording with the Cook County Recorder of Deeds) were created by Thomas G. Milsted. The first of Milsted's two subdivisions included the 1200 and 1300 blocks of Glenlake Avenue and was recorded on June 17, 1890. The second included the south side of the 1200 and 1300 blocks of Hood Avenue and was recorded December 22, 1890. Edgewater Glen's third subdivision, recorded on April 4, 1892, was called the Brost and Kemper Addition to Edgewater. It included the north side of the 1200 and 1300 blocks of Hood Avenue. The last of the eastern half subdivisions was created by John Lewis Cochran, Edgewater's founding father, and recorded on August 13, 1893. It was called Cochran's Fourth Addition to Edgewater and included the 1200 and 1300 blocks of Norwood Street. (See IMAGE 27 for a subdivision map of Edgewater Glen.)

Residential development in the subdivided areas of Edgewater Glen was slow in the 1890s and early 1900s. The earliest identified building permit in Edgewater Glen was for the house at 1215 W. Norwood Street, which was issued November 2, 1893. Prior to 1900 there were only 14 houses in Edgewater Glen, all but four of which were in Cochran's Fourth Addition. Of these houses, five were built by Cochran for resale.<sup>5</sup>

The western half of the Edgewater Glen, between Glenwood Avenue and Clark Street, remained part of the Kransz farm until the early 1900s when the Kransz family became subdividers and developers of their large acreage. The first Kransz subdivision in Edgewater Glen was recorded April 8, 1903, and included the 1400 and 1500 blocks of Hood Avenue (both sides) and the 1400 and 1500 blocks of Glenlake Avenue (north side only). The second Kransz subdivision was recorded October 12, 1904, and included the 1400 and 1500 blocks of Glenlake Avenue (south side only) and the 1400 and 1500 blocks of Norwood Street (both sides).

In September 1903, four permits were issued to the Weber, Kransz & Company for a total of 45 houses, all on Hood Avenue within the Kransz family's first subdivision in Edgewater Glen. Henry P. Kransz and Nicholas Kransz Jr., sons of pioneer Nicholas Kransz Sr., were involved in the family's real estate business and both lived in Edgewater Glen: Henry at 1519 W. Hood Avenue and Nicholas, Jr. at 1502 W. Glenlake Avenue. The Weber in Weber & Kransz refers to Bernard F. Weber, who married Annie M. Kransz, daughter of Nicholas, Sr. The company was thus very much a family affair. (See IMAGE 31 for Weber, Kransz & Co. display advertisement.)

A review of the Sanborn Fire Insurance Map from 1905 shows that residential development in Edgewater Glen was then primarily clustered on both sides of Hood Avenue, especially its 1400 and 1500 blocks, and consisted of single-family houses. In contrast, the 1200 through 1500 blocks of Glenlake Avenue were undeveloped in 1905, and Norwood Street in Edgewater Glen featured only a scattered array of houses on its 1200 and 1300 blocks. (See IMAGES 20-22 for 1905 Sanborn Maps. Present-day Glenwood Avenue was named Southport and Greenview Avenue was named Perry at that time.)

Edgewater Glen reached residential maturity by 1928, as evidenced by the Sanborn Fire Insurance Map from that year, which shows that all parcels in the district were developed with single-family houses, which were intermixed with about three dozen two-flats and other small-scale apartment buildings. Nearly all buildings had garages that opened onto the alleys. (See IMAGES 23-26 for 1928 Sanborn Maps.)

Most residential buildings in Edgewater Glen were erected within a fifteen-year timeframe—1900 to 1915—and dozens were either designed or built by the same architect of contractor, respectively. For example, architect Edward Benson designed a total of 41 houses in the district that are similar in appearance, 35 of which are located on the 1400 and 1500 blocks of Norwood Street. Contractor Roy Knauer built 31 houses in the district, 26 of which are on the 1200 and 1300 blocks of Glenlake Avenue. Thus, the cohesive housing stock within Edgewater Glen was in large part controlled by these individuals—as well as the Kransz family—who together helped define the character of the district as one of single-family houses featuring mainly vernacular versions of the Queen Anne and Prairie styles. (See IMAGES 28-30 for historic photos of houses in the district.)

The early 1900s through the 1920s was also a period of rapid growth for the larger Edgewater community, which became built up with a plethora of two- to six-flat apartment buildings. The apartment building boom of this period included a strip of "common corridor" buildings and residential hotels concentrated between Winthrop and Kenmore Avenues along the community's eastern edge. North Sheridan Road developed with large single-family homes and mansions during this period. Edgewater became more densely populated in the post-World War II period, especially east of Broadway, near the lakefront. Along the Winthrop-Kenmore corridor, two- to six-flat apartments were replaced with larger multi-family buildings and nearly all the mansions along Sheridan Road were eventually replaced by a wall of high-rise apartment towers. 8

Today, the Edgewater Glen District remains a distinctive neighborhood of mainly single-family houses on tree-lined streets set within a community mainly comprised of multi-family apartment buildings of all types. The district is virtually unchanged from its appearance in the 1920s; only six houses were constructed after that time. The only comparable neighborhood within Edgewater is the Lakewood-Balmoral District on the southeast side of the community. Like Edgewater Glen, it is characterized by large, single-family houses from the turn of the twentieth century, although its residential building stock is more stylistically diverse. Lakewood Balmoral was designated a NRHP district in 1997 under Criterion A for Community Planning and Development.

## **Architectural Styles in the District**

Edgewater Glen has a total of 349 residential buildings that are contributing to the district. Nearly half of the contributing buildings (156), comprise vernacular versions of the Prairie style of architecture, including the boxy, American Foursquare subtype of this style. The second dominant style in the district is the Queen Anne (107)—distinguished by its steeply pitched gable rooflines—although below the roofline, Edgewater Glen's houses in this style strongly resemble their American Foursquare counterparts. Essays on both styles—and examples of their use in the district—are below.

The district's cohesive ensemble of Prairie and Queen Anne style houses—most of which feature full-façade porches—are joined by 11 houses designed in the Craftsman style, as well as examples of the Chicago Bungalow form (4), the Dutch Colonial style (4), the Italian Renaissance style (1), and the Colonial Revival style (1). Six houses do not exhibit any discernable style.

### **QUEEN ANNE**

The Queen Anne was the dominant style of domestic building in the United States from about 1880 until 1910. An eclectic and picturesque style, it was used for urban, suburban and rural residences. The style was named and popularized by a group of nineteenth-century English architects led by Richard Norman Shaw (1831-1912). Shaw's sprawling manor houses were published in the architectural press starting in the 1870s, and thus came to be known, admired, and imitated by American architects. The name is rather inappropriate, for the historical precedents used by Shaw and his followers had little to do with Queen Anne or the formal Renaissance architecture that was dominant during her reign (1702-1714). Instead, they borrowed most heavily from late medieval rural models of the preceding Elizabethan and Jacobean eras.<sup>9</sup>

H.H. Richardson's Watts-Sherman House in Newport, Rhode Island (1874) is generally considered to be the first American example of the Queen Anne style. Richardson followed Shaw very closely in the design for this half-timbered house, while providing a degree of American character by substituting shingles for tiles to sheath its upper walls, and stone for brick as cladding for the ground story. 10 A few high-style examples followed in the 1870s, and by 1880 the style was being spread throughout the country by widely circulated pattern books and the first architectural magazine, The American Architect and Building News. 11 The expanding railroad network also helped popularize the style by making pre-cut architectural details conveniently available through much of the nation.

Queen Anne houses feature asymmetrical facades with an emphasis on verticality. Irregularities in ground plan were facilitated by the widespread adoption of balloon framing techniques in the late nineteenth-century. Wall surfaces typically feature a mixture of cladding materials and textures, such as brick or stone on the ground level and upper floors covered with horizontal boards, stucco, or shingles shaped in varying designs. In masonry houses, texture is created through differing patterns of brick courses or the insertion of terra cotta panels. Halftimbering, when used, is typically seen in the roof gables, which also may feature patterned shingles or more elaborate motifs, such as appliques of stylized sunbursts or sunflower motifs.

The Queen Anne style is generally characterized by asymmetry and verticality in its overall shape, façade, and roof. A mixture of cladding materials and textures, as well as elements such as window bays, are used to break up the surface of the walls. Queen Anne houses display a variety of window types, such as casements, doublehung, and oriels. Casements windows are often arranged in groups, and double-hung windows may have upper sashes outlined with small glass squares.

Porches are also hallmarks of the Queen Anne style. The earlier homes in the style have milled porch columns and balustrades, while those after 1893 (reflected the influence of the World's Columbian Exposition in Chicago) often have Classical columns and simpler square wood piers, either full-height or shorter versions set upon piers. Houses in the Queen Anne style feature steeply pitched roofs, either gabled or hipped, and the latter may have one or more lower cross gables. Gables are sometimes sheathed with contrasting materials, such as patterned shingles, and may include decorative ornament or a Palladian window.

Queen Anne style houses in Edgewater Glen are typically 2 ½ stories in height and distinguished largely by their rooflines, which are front-gabled, side-gabled, cross-gabled, or hipped. The most prevalent roofline is front-gabled; the gable end is sometimes pedimented and may be sheathed in shingles. Hipped versions often have corner turrets or towers of varying shapes, which are placed on one corner of the front facade. Queen Anne

houses in Edgewater Glen were originally sheathed in wood clapboard, which has been covered over/replaced by vinyl siding in many cases. The installation of vinyl siding typically does not detract from the building's original massing and fenestration patterns, however.

Many of the district's gable-roof Queen Anne houses closely resemble their American Foursquare counterparts beneath the roofline. They generally have full-width porches with supports that consist of either Classical columns or simple, squared piers. Full-width porches that are enclosed typically feature a continuous strip of windows. Front entrances are typically off-center, and three-sided window bays are exceedingly common on the front façades, either on one or both stories. Houses often feature varied fenestration, which may include both casements and double-hung windows. Porches are generally full width, have shed or hip roofs, and many are enclosed.

The house at **1514 W. Glenlake Avenue** is an example of a front-gable Queen Anne house with a partial-width enclosed porch, a three-sided window bay, and a window recessed within a round-arch opening in the pedimented front gable (IMAGE 1). A Queen Anne house with a cross-gable roofline is at **1415 W. Glenlake Avenue**, which also features a full-width open porch with Doric columns and three-sided window bays on both floors (IMAGE 2). The house at **1521 W. Glenlake Avenue** is a side-gable example of the Queen Anne style with a full-width open porch and a polygonal corner tower with conical roof (IMAGE 3).

#### **PRAIRIE**

The Prairie style of architecture is often regarding as the first indigenous residential architectural style in the U.S. Frank Lloyd Wright's early work is in this style, which he and his contemporaries originated in the Chicago area. Landmark examples are concentrated in that city's early 20<sup>th</sup> century suburbs, especially Oak Park and River Forest. Vernacular examples were spread widely by pattern books and popular magazines; they are common in early 20th century suburbs throughout the county. Most examples were built between 1905 and 1915; the style quickly faded from fashion after World War II.

Identifying features of Prairie architecture include low-pitched roofs with wide overhangs; flat stucco or brick wall treatment; casement windows (often leaded), clustered in horizontal bands; and the omission of ornamentation, except for modest, geometric wood banding in some stucco examples.

Virginia and Lee McAlester's book, *A Field Guide to American Houses* (New York: Alfred A. Knopf, 1984), identifies several principal vernacular subtypes to the Prairie style, three variations of which are prevalent in Edgewater Glen.

The hipped roof, front entry, with open or enclosed full-width porch subtype is also commonly known as the American Foursquare. These houses are usually two to 2½ stories tall with a hipped or pyramidal roof, a full-width front porch with classical or squared-off columns and piers, overhanging eaves, and a central dormer. They are typically square or nearly square in plan with four equal-sized areas, one on each corner, plus a side stairwell. Many plan book and catalog companies featured Foursquare designs between 1900 and 1925. Quintessential examples of the American Foursquare subtype of the Prairie style are the stucco-clad houses at 1303 W. Norwood Street and 1249 W. Glenlake Avenue, both of which have square footprints and have hip roofs with overhanging eaves and a central, hip dormer. The house on Norwood has a full-width open porch with squared wood columns and three-sided window bays on both floors of the front façade, while the Glenlake Avenue house has as full-width, hip-roof, enclosed porch (IMAGES 5-6).

The **hipped roof, no front entry subtype** is like the type described above but with inconspicuous side entrances. This is a favorite form for smaller, architect-designed Prairie houses and for those built on narrow

urban lots. There are numerous examples of this subtype in Edgewater Glen, which typically have full-width, enclosed sunporches featuring horizontal strips of windows. An excellent example is the stucco-clad house at **1315 W. Hood Avenue** had a full-width enclosed porch with a strip of windows, side entry, two window bays on a front façade, and a hip roof with overhanging eaves and gable dormer (IMAGE 7).

In the **gabled roof subtype**, gables replace the more typical hipped roofs. Vernacular examples usually have simple front- or side-gabled roofs. Tudor secondary influences are common, especially false half-timbering in gables.

#### **CRAFTSMAN**

The other important style from the early 20<sup>th</sup> century not based on historic precedent is the Craftsman style. Also having low-pitched roofs with deep overhanging eves, Craftsman homes have exposed rafter ends, decorative brackets, or knee braces under shallow gable roofs, dormers, and a deep front porch. Windows are often double-hung sash with three panes in the upper sash and one in the lower. The Craftsman style was especially popular between 1901 and 1916, when the architect and furniture maker Gustav Stickley published his magazine, *The Craftsman*, although they were built into the 1920s.

There are 11 examples of Craftsman style houses in the Edgewater Glen District. Representative examples are 1½ stories in height with stucco or brick sheathing, front-gable, side-gable, or hip-on-gable roofs with exposed rafter ends, full- and partial width porches, and bands of casement windows (IMAGE 8).

#### CHICAGO BUNGALOW

The Chicago bungalow was the predominant residential building type constructed mainly in the 1920s in the city's "Bungalow Belt," the crescent shape ring of communities on the outskirts of the city, which experienced rapid development in the early twentieth century. Its architectural form—influenced by both the California Craftsman style frame bungalow and the Prairie style of architecture—is unique to Chicago. It was designed to suit the city's narrow, 25 by 125-foot lot size and cold climate with its rectilinear shape and insulated, solid brick construction.

A hallmark of the Chicago bungalow is a projecting, living room bay, which could be rectilinear, rounded, or an angled shape. Windows in such bays are typically arranged in groups, emphasizing horizontality, and those of fancier bungalows feature colored, leaded glass with geometric shapes. Builders often used varied fenestration—including both double-hung and casement windows—in different sizes and shapes to provide each house with a unique appearance. There are four examples of the Chicago Bungalow in Edgewater Glen, all of which have a projecting, living room bay (IMAGE 9).

#### **DUTCH COLONIAL**

The Colonial Revival style was based on elements of both Federal and Georgian architecture, which were popular styles in America in the 1700s and early 1800s. The Colonial Revival and its subtypes—including the Dutch Colonial—dominated domestic architecture in the U.S. during the first half of the 20<sup>th</sup> century. The hallmark of the Dutch Colonial is the steeply pitched gambrel roof containing almost a full second story of floor space; these have either separate dormer windows or a continuous shed dormer with several windows. The most common form has a front-facing gambrel roof was the most common form from about 1895 to 1915, when side gambrels, usually with long shed dormers, became the predominant form in the 1920s and 1930s (IMAGE 10).

## **Key Architects/Builders**

Two of the most prolific architects/builders in the Edgewater Glen District were Edward Benson (41 buildings) and Roy E. Knauer (31 buildings), biographies of whom are below. More extensive permit research would likely reveal that the two men designed more than the 72 buildings identified as their works thus far.

Preliminary research also shows that the district includes buildings designed by C. Hoerman (3), Perley Hale (6), Neils Buck (3), and A.E. Norman (4), all of whom were also prominent local architects who designed many other houses in the larger Edgewater community and elsewhere in Chicago. More intensive research may also show that these architects designed additional houses in the district.

#### Edward Benson, Architect

Edward Benson (1868-1939) was born on March 25, 1859, in the parish of Kallerstad, Jonkopings Ian, Sweden, the son of Bengt and Christina Nelson, who were farmers. After completing grammar school in his native state in 1873, Benson became a student in the Technical School of Stockholm between 1879 and 1881. He spent the next two years in an architectural institute in Stockholm and then took a course in a business college from 1883-84. After the completion of his education, he found employment as a draftsman, and from 1884-88, he was placed in charge of the construction of apartment buildings and various school buildings in Stockholm.<sup>12</sup>

In 1888, Benson arrived in the United States and went directly to Chicago where he initially found work as a carpenter and later as a bricklayer. A contemporary biography of Benson stated:

After two or three years of practical work he had the occasion to draw his first plans for a Chicago building on the south side. Since then he has had decided success as an architect and has been the designer of nearly two thousand buildings, including apartments, hospitals, churches, factories and office buildings, etc. This phenomenal success is due to his superior methods, his personal supervision of every enterprise and his integrity.<sup>13</sup>

The American Contractor's Chicago Building Permit Column, 1898-1912, identifies 98 buildings designed by Benson, most of which were on the North Side. Benson was elected president of the American Institute of Architects at some point prior to 1917, at which time he maintained a business office at 118 N. LaSalle Street. Benson was married in 1885 to Ida Louisa Flodin of his native parish in Sweden and the couple had four children. <sup>14</sup> The 1920 census shows that the 60-year-old Benson then lived in Edgewater, in a three-flat at 5520 Glenwood Avenue with his wife and three children. By 1930, he had moved with his wife to Clearwater, Florida. He died in 1934 at the age of 75.

The 41 residential buildings in Edgewater Glen identified as Benson designs are listed below. <sup>15</sup> Nearly all of Benson's designs in Edgewater Glen feature various iterations of the Prairie style and were constructed between 1905 and 1915. All are detached, single-family homes except for the two-flat at 1242 Glenlake. Thirty-six of the 41 buildings are in the Kransz 2<sup>nd</sup> Addition to Edgewater and two are in the Kransz 1<sup>st</sup> Addition to Edgewater. These buildings are all located on land once occupied by the Nicholas Kransz farm and were commissioned by Henry P. Kransz, whose company subdivided and developed the farm of his father, Nicholas Kransz.

#### Roy E. Knauer, Real Estate Broker and Builder

Roy E. Knauer (1883-1943) was a real estate broker and builder of Edgewater homes. He was born on September 23, 1883, the only son of Edmund and Mary Simon Troost Knauer. His father, Edmund, was listed as one of the incorporators of the Grand Central Elevated Railway Company and was also involved in real estate. Knauer was not a subdivider, unlike other builders of Edgewater homes, such as J.L. Cochran, W.H. Cairnduff, and the Kransz family. Rather, he bought lots from subdividers and built speculative houses on them for resale. Knauer was only 23 years of age when he purchased his first lots and built his first houses in 1907, when his first advertisement for speculative houses appeared in the *Chicago Tribune*. <sup>16</sup>

The 31 houses in Edgewater Glen identified as built by Roy Knauer are listed below. 17 Twenty-six of Knauer houses were located on the 1200 and 1300 blocks of Glenlake Avenue. The building permits for these houses list only Roy Knauer's name as the builder and do not identify an architect. Knauer lived in one of his houses— 1239 Glenlake Avenue—from 1911 until at least 1923. He moved to the North Shore suburb of Kenilworth by 1930, according to the U.S. Census.

Knauer served as vice president of the Chicago Real Estate Board in the early 1930s and maintained real estate offices at 6140 Broadway Avenue, at the southwest corner of Hood Avenue (razed) and at 6168 Broadway Avenue (razed). By 1928, he moved his office to 2344 Devon Avenue in Rogers Park, where it remained until his death in 1943 at the age of 58.<sup>18</sup>








