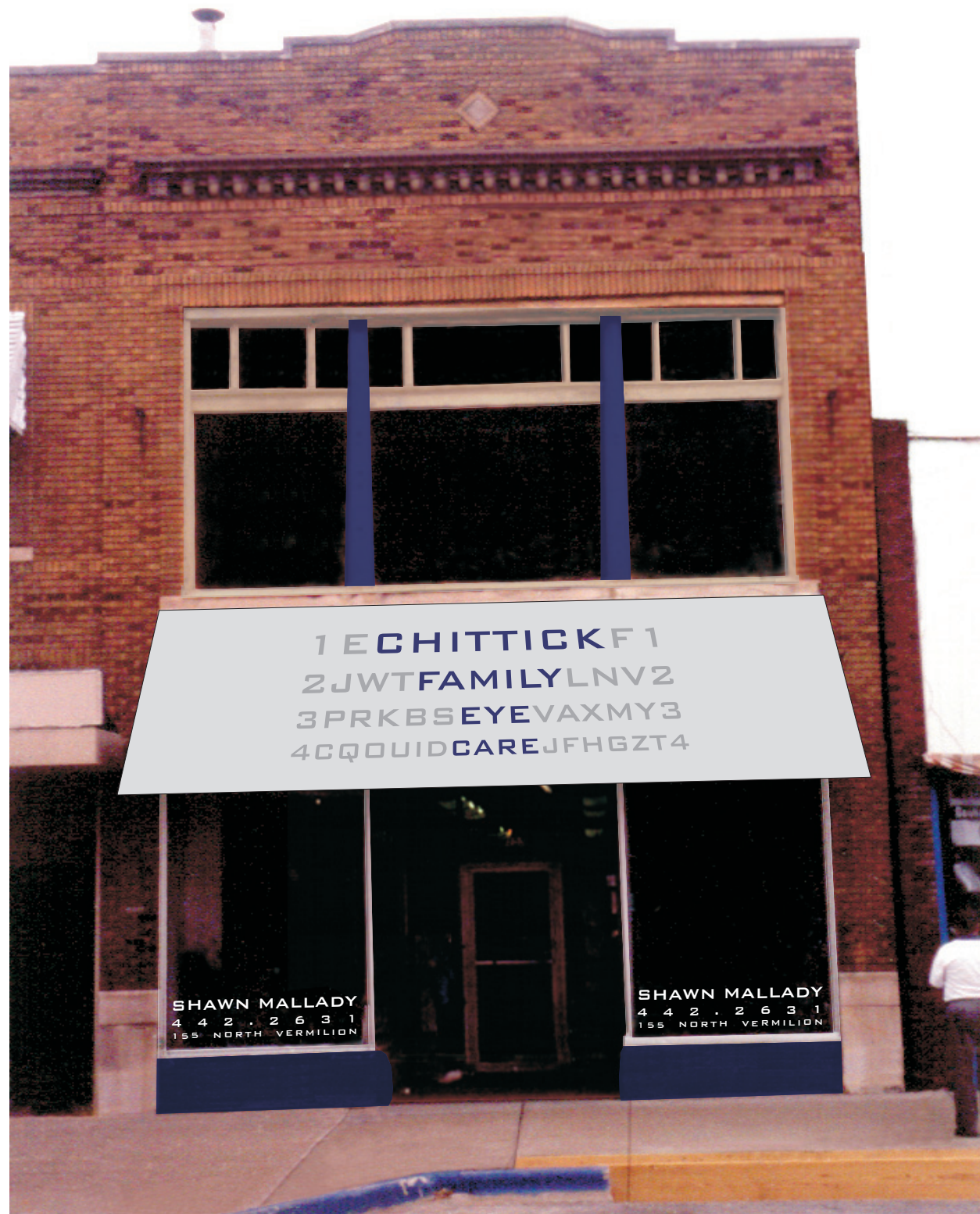

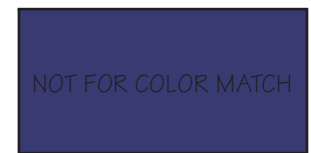
AWNING GRAPHIC DETAIL

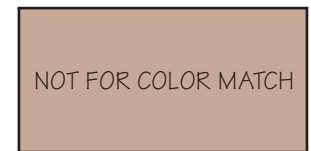

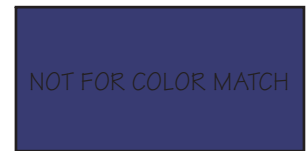
