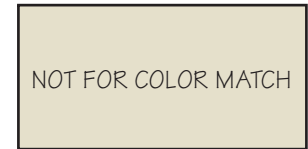

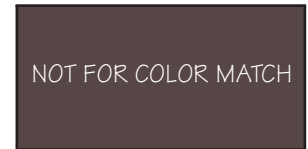


FLUSH-MOUNTED SIGN SUGGESTION

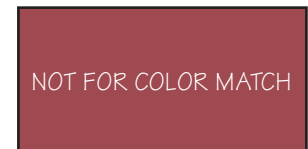
