

**MEMORANDUM OF AGREEMENT AMONG
THE HOUSING AUTHORITY OF COOK COUNTY,
COOK COUNTY DEPARTMENT OF PLANNING AND DEVELOPMENT,
NATIONAL PUBLIC HOUSING MUSEUM, AND
THE ILLINOIS STATE HISTORIC PRESERVATION OFFICE
REGARDING THE DEMOLITION OF THE JOHN MACKLER HOMES AND
THE WEST PORTION OF THE SUNRISE APARTMENTS
IN CHICAGO HEIGHTS, ILLINOIS
(SHPO LOG #002011221)**

WHEREAS, the Housing Authority of Cook County (HACC) plans to demolish the John Mackler Homes at 293 to 299 East 12th Street, 301 to 303 East 12th Street, and 1100 to 1140 5th Avenue and the west portion of the Sunrise Apartments at 281 to 287 East 12th Street, 1101 to 1133 Claude Court, and 1110 to 1116 Claude Court (“Undertaking”) in Chicago Heights, Cook County, IL, as shown in Exhibit A; and

WHEREAS, the sixty-five (65) units planned for demolition form a portion of a larger complex of public housing properties in Chicago Heights, comprised of the John Mackler Homes, Sunrise Apartments, and Daniel Bergen Homes (MSB); and

WHEREAS, there are 107 units that are not planned for demolition under this Undertaking and that are considered a part of either the east portion of the Sunrise Apartments or the Daniel Bergen Homes; and

WHEREAS, the Undertaking involves property demolition by the HACC which the U.S. Department of Housing and Urban Development (HUD) requires be subject to review under Section 106 of the National Historic Preservation Act of 1966, as amended, 54 U.S.C. § 306108, and its implementing regulations (36 CFR Part 800) (Act); and

WHEREAS, the Cook County Department of Planning and Development (Cook County) is the Responsible Entity under 24 CFR Part 58 “Environmental Review Procedures for Entities Assuming HUD Environmental Responsibilities”; and

WHEREAS, the HACC has consulted with the Illinois State Historic Preservation Office (Office), a Division of the Illinois Department of Natural Resources (IDNR), pursuant to the Act; and

WHEREAS, the Office currently resides within IDNR, and the Director of IDNR is the duly designated State Historic Preservation Officer (SHPO); and

WHEREAS, on February 19, 2019, the SHPO determined that the John Mackler Homes and Sunrise Apartments are eligible to be listed on the National Register of Historic Places (NRHP) under Criterion A for associations with the development of postwar public housing and urban renewal and under Criterion C for planning at the local level of significance; and

WHEREAS, on February 17, 2021 the SHPO determined that this Undertaking would have an adverse effect on the John Mackler Homes and Sunrise Apartments; and

WHEREAS, on June 7, 2021, the SHPO determined that the Daniel Bergen Homes are eligible to be listed on the National Register of Historic Places (NRHP) under Criterion A for associations with the development of postwar public housing and urban renewal and under Criterion C for planning at the local level of significance; and

WHEREAS, on April 16, 2021, the SHPO invited the National Public Housing Museum (NPHM) to participate in consultation and to sign this Memorandum of Agreement (Agreement) as an Invited Signatory, which the NPHM accepted; and

WHEREAS, in accordance with 36 CFR § 800.6(a)(1) and 36 CFR § 800.10(b), HACC has notified the Advisory Council on Historic Preservation (ACHP) of the adverse effect determination, and on June 9, 2021, the ACHP has chosen not to participate in the consultation pursuant to 36 CFR§ 800.6(a)(1)(iii);

NOW, THEREFORE, HACC, Cook County, NPHM, and the SHPO agree that the Undertaking shall be implemented in accordance with the following stipulations in this Agreement in order to mitigate the adverse effects of this Undertaking to the NRHP-eligible properties.

STIPULATIONS

I. MITIGATION

The HACC and SHPO have acknowledged and agreed that due to the risk of environmental pollutants and potential hazard to human habitation recorded in the Phase I Environmental Site Assessment and HUD 24 CFR Part 58 Environmental Assessment for John Mackler Homes and the west portion of the Sunrise Apartments, mitigation shall consist of the following.

A. Oral History Audio Recordings:

1. HACC and NPHM shall collaborate to identify current and past residents of MSB who agree to provide oral-history narratives of their lives and experiences in public housing, including discussions of social and Environmental Justice issues. NPHM shall coordinate and digitally record the narratives. There shall be a minimum of seven (7) Oral History Audio Recordings.
2. Upon completion of Stipulation I.A.1, NPHM shall submit evidence of digital audio file capture to SHPO.
3. NPHM will maintain custody of the Oral History Audio Recordings. Participants may request access to their oral histories once NPHM's oral history archive is made available to the general public by NPHM. Such requests for access shall be made to NPHM. SHPO will obtain copies from NPHM as needed.

4. In the event that within twelve (12) months of the date of execution of this Agreement HACC and NPHM are unable to recruit at least seven (7) current and/or past residents of MSB who agree to provide oral-history narratives, SHPO shall not require that HACC and NPHM recruit additional residents for a total of seven (7) to meet I.A.1.
5. SHPO approval of the demolition of the John Mackler Homes and the west portion of Sunrise Apartments are not contingent on the completion of Stipulations I.A.1 through I.A.4.

B. Photography

1. HACC must take accurate, high-resolution, color, digital photographs of the exterior and representative interiors of MSB.
2. Upon completion of Stipulation I.B.1, HACC shall submit the digital images to SHPO for review and comment.
3. Upon SHPO approval of the digital images stipulated in Stipulation I.B.1, demolition of the John Mackler Homes and the west portion of the Sunrise Apartments may commence.
4. HACC shall provide SHPO and NPHM an external storage device, e.g. an external hard drive, containing the images.
5. SHPO shall make the images available on its website.
6. NPHM shall store the images on its secure servers until a public venue for the photographs and oral-history audio recordings has been determined.

- C. Signatories to this Agreement agree and acknowledge that the mitigation in Stipulation I shall satisfy the mitigation requirement for any future undertaking with an adverse effect on the east portion of the Sunrise Apartments and/or the Daniel Bergen Homes. No further mitigation shall be required for any future undertaking generating an adverse effect upon the remaining 107 units comprising the east portion of the Sunrise Apartments and the Daniel Bergen Homes.

II. DURATION

This Agreement shall be effective until such time as all of its terms are satisfied, or it is amended or terminated and replaced. Prior to such time, Cook County may consult with the other Signatories and Invited Signatories to reconsider the terms of the Agreement and amend it in accordance with Stipulation VI AMENDMENTS below. Cook County shall notify the signatories as to the course of action it will pursue.

III. POST-REVIEW DISCOVERIES

If potential historic properties are discovered or unanticipated effects on historic properties found, Cook County shall consult with the SHPO immediately and make reasonable efforts to avoid, minimize, or mitigate adverse effects to such properties. In the event of an unanticipated discovery of human remains or burials, Cook County understands and agrees that it must immediately stop work within the area of discovery and consult with the SHPO.

IV. MONITORING AND REPORTING

Each year following the execution of this Agreement until it expires or is terminated, Cook County shall provide all parties to this Agreement and the ACHP a summary report detailing work undertaken pursuant to its terms. Such report shall include any scheduling changes proposed, any problems encountered, and any disputes and objections received in Cook County's, HACC's and NPHM's efforts to carry out the terms of this Agreement.

V. DISPUTE RESOLUTION

Should any Signatory or Invited Signatory to this Agreement object at any time to any actions proposed or the manner in which the terms of this Agreement are implemented, Cook County shall consult with the signatories to resolve the objection. If the signatories cannot agree regarding a dispute, the signatories shall:

- A. Forward all documentation relevant to the dispute, including any timely advice or comments regarding the dispute from the signatories and concurring parties, and the Cook County's proposed resolution, to the ACHP. The ACHP shall provide Cook County with its advice on the resolution of the objection within thirty (30) days of receiving adequate documentation. Prior to reaching a final decision on the dispute, Cook County shall prepare a written response that takes into account any timely advice or comments regarding the dispute from the ACHP, signatories and concurring parties, and provide them with a copy of this written response. Cook County will then proceed according to its final decision.
- B. If the ACHP does not provide its advice regarding the dispute within the thirty (30) day time period, Cook County may make a final decision on the dispute and proceed accordingly. Prior to reaching such a final decision, Cook County shall prepare a written response that takes into account any timely comments regarding the dispute from the signatories and concurring parties to the Agreement and provide them and the ACHP with a copy of such written response.
- C. Cook County's, HACC's and NPHM's responsibility to carry out all other actions subject to the terms of this Agreement that are not the subject of the dispute remain unchanged.

VI. AMENDMENTS

This Agreement may be amended when such an amendment is agreed to in writing by all Signatories and Invited Signatories. The amendment will be effective on the date a copy is signed by all of the signatories. Signatories to this Agreement agree that if a non-signatory entity wishes to be a Consulting Party to this undertaking, that said entity's consultation need not require their addition as a signatory to this Agreement.

VII. TERMINATION

If any signatory to this Agreement determines that its terms become impossible to carry out, that party shall immediately consult with the other signatories to attempt to develop an amendment per Stipulations V and VI above. If within thirty (30) days an amendment cannot be reached, any signatory may terminate the Agreement upon written notification to the other signatories.

If this Agreement is terminated, and prior to work continuing on the Undertaking, Cook County will either (a) execute a Memorandum of Agreement pursuant to 36 CFR § 800.6 or (b) request, take into account, and respond to the comments of the ACHP under 36 CFR § 800.7. Cook County shall notify the signatories as to the course of action it will pursue.

VIII. COUNTERPARTS; FACSIMILE OR .PDF SIGNATURES

This Agreement may be executed in counterparts, each of which shall be considered an original and together shall be one and the same Agreement. A facsimile or .pdf copy of this Agreement and any signatures thereon will be considered for all purposes as an original.

IX. DISTRIBUTION OF AGREEMENT

In order to meet the requirements of Section 106. 36 CFR § 800.6(b)(1)(iv), upon the execution of this Agreement and prior to approving the Undertaking, Cook County must transmit to the ACHP the executed Agreement along with the documentation specified in Section 800.11(f).

EXECUTION of this Agreement by HACC, Cook County, NPHM, and SHPO and the implementation of its terms evidence that the HACC, Cook County, NPHM, and SHPO afforded the ACHP an opportunity to comment on the effects of the Undertaking in compliance with the Act.
