WHEREAS, the Signatories are in process of drafting a new Statewide Section 106 Programmatic Agreement (PA) regarding the Federal Aid Highway Program in Illinois;

WHEREAS, the Signatories agree to extend the PA for Federal-Aid Transportation Projects in the State of Illinois to March 6, 2025 or until the execution of the new Statewide Section 106 PA regarding the Federal Aid Highway Program in Illinois, whichever comes first;

NOW, THEREFORE, FHWA, SHPO, ACHP, and IDOT, as signatories to this PA, agree that IDOT may continue use of the Federal-Aid Transportation Projects PA for Section 106 compliance.
