WHEREAS, the Signatories are in process of drafting a new Statewide Section 106 Programmatic Agreement (PA) regarding the Federal Aid Highway Program in Illinois that involves Tribal partners in the entirety of the consultation process; and

WHEREAS, the Signatories agree to extend the Agreement to March 6, 2027;

NOW, THEREFORE, FHWA, SHPO, ACHP, and IDOT, as signatories to this Agreement, agree that IDOT may continue use of the Agreement for Section 106 compliance.
