

To Whom It May Concern:

Attached is the listing of all Department of Natural Resources-sponsored projects exempted from archaeological survey during FY2019 under the terms of the programmatic agreements between the Illinois State Historic Preservation Office (ISHPO), under the former Illinois Historic Preservation Agency, and the Illinois Department of Natural Resources (IDNR). The US Fish and Wildlife Service has also applied use of the exemptions for their projects on IDNR State lands. Two sheets with the exemption codes are appended.

The IDNR-Division of Real Estate Services and Consultation seeks ISHPO concurrence that within the programmatic agreements, the listed undertakings, including Abandoned Mine Land Reclamation projects, comply with state and federal regulations pertaining to cultural resources. The IDNR programmatic agreement with the Fish and Wildlife Service requires that we provide a copy of the ISHPO concurrence by September 30, therefore a timely response would be appreciated.

## CLASSES OF EXEMPT UNDERTAKINGS

The following classes of undertakings are exempt from IHPA review except as noted:

1. Projects not involving structures when project area is 5 acres or less in size except: a) if known archaeological sites or unregistered cemeteries are present within the project area.
2. Vegetation clearing and/or burning of trees and shrubs less than six (6) inches in diameter in previously plowed fields.
3. Road widening equal to or less than three (3) meters on either side of existing road bed except within areas designated as archaeologically sensitive as listed in Appendix A or within areas of high archaeological potential within other IDOC managed properties as listed in Appendix B.
4. Utility line construction or rehabilitation with width equal to or less than 3 meters except within areas designated as archaeologically sensitive as listed in Appendix A.
5. Development of foot trails where disturbance is limited to surface vegetation only and is not located in an archaeologically sensitive area as listed in Appendix A.
6. Project areas of less than 25 square meters in archaeologically sensitive areas as listed in Appendix A or within areas of high archaeological potential within other IDOC- managed properties as listed in Appendix B.
7. Project areas where previous cultural resource assessments have determined either no or non-significant resources are present and have been reviewed and approved by IHPA post 1985.
8. Projects upon landforms less than 50 years of age with no potential for buried archaeological resources.
9. Grounds maintenance including mowing, pruning, seeding and any other non-ground disturbing activities.
10. Modification/rehabilitation of structures less than 40 years old.
11. Building maintenance of all structures including electrical work, heating and ventilation systems and plumbing on existing facilities; replacement of missing or damaged glass and caulking; and exterior and interior painting, or replacement in-kind of other materials.
12. Projects within areas of documented land disturbance not involving structures, including but not limited to areas of surface coal mining.
13. (Added Sept. 2012) Vegetation Improvement where no significant or potentially significant site is involved.

## **CATEGORIES OF EXEMPT PROJECTS UNDER THE PROGRAMMATIC AGREEMENT CONCERNING MINE LANDS**

1. Areas previously disturbed by surface mining and mine refuse disposal.
2. Land impacted by planned subsidence which will not be inundated by water.
3. Incidental boundary revisions, up to 5 acres, to existing permits with similar geographic settings where no National Register eligible/listed sites were found in previous surveys.
4. Filling and sealing shafts.
5. Highwall embankments and refuse projects utilizing disturbed spoil material or pre-approved borrow.
6. Flood control projects that involve drainage control with rip-rap on previously disturbed lands and culvert replacement. No historic structures will be affected.
7. Guardrail installation.
8. Removal of redeposited mine sediment on land adjacent to mine.
9. Water-treatment projects within previously disturbed lands or restricted to water.
10. Remedial projects.
11. Land disturbances, including but not limited to off-site borrow and grading high walls, 5 acres or less.
12. Emergency filling and sealing pit subsidence in rural areas where historic properties are not effected.
13. Emergency filling and sealing pit subsidence projects in urban areas where the intent is to stabilize structures to ensure protection of property.
14. Shadow areas in which there will be no surface disturbance.
