CLASSES OF EXEMPT UNDERTAKINGS

The following classes of undertakings are exempt from IHPA review except as noted:

1. Projects not involving structures when project area is 5 acres or less in size except: a) if known archaeological sites or unregistered cemeteries are present within the project area.
2. Vegetation clearing and/or burning of trees and shrubs less than six (6) inches in diameter in previously plowed fields.
3. Road widening equal to or less than three (3) meters on either side of existing road bed except within areas designated as archaeologically sensitive as listed in Appendix A or within areas of high archaeological potential within other IDOC managed properties as listed in Appendix B.
4. Utility line construction or rehabilitation with width equal to or less than 3 meters except within areas designated as archaeologically sensitive as listed in Appendix A.
5. Development of foot trails where disturbance is limited to surface vegetation only and is not located in an archaeologically sensitive area as listed in Appendix A.
6. Project areas of less than 25 square meters in archaeologically sensitive areas as listed in Appendix A or within areas of high archaeological potential within other IDOC- managed properties as listed in Appendix B.
7. Project areas where previous cultural resource assessments have determined either no or non-significant resources are present and have been reviewed and approved by IHPA post 1985.
8. Projects upon landforms less than 50 years of age with no potential for buried archaeological resources.
9. Grounds maintenance including mowing, pruning, seeding and any other non-ground disturbing activities.
10. Modification/rehabilitation of structures less than 40 years old.
11. Building maintenance of all structures including electrical work, heating and ventilation systems and plumbing on existing facilities; replacement of missing or damaged glass and caulking; and exterior and interior painting, or replacement in-kind of other materials.
12. Projects within areas of documented land disturbance not involving structures, including but not limited to areas of surface coal mining.
13. (Added Sept. 2012; log 004200112) Vegetation Improvement where no significant or potentially significant site is involved. See attached letter.

CATEGORIES OF EXEMPT PROJECTS UNDER THE PROGRAMMATIC AGREEMENT CONCERNING MINE LANDS

1. Areas previously disturbed by surface mining and mine refuse disposal.
2. Land impacted by planned subsidence which will not be inundated by water.
3. Incidental boundary revisions, up to 5 acres, to existing permits with similar geographic settings where no National Register eligible/listed sites were found in previous surveys.
4. Filling and sealing shafts.
5. Highwall, embankments and refuse projects utilizing disturbed spoil material or pre-approved borrow.
6. Flood control projects that involve drainage control with rip-rap on previously disturbed lands and culvert replacement. No historic structures will be affected.
7. Guardrail installation.
8. Removal of redeposited mine sediment on land adjacent to mine.
9. Water-treatment projects within previously disturbed lands or restricted to water.
10. Remedial projects.
11. Land disturbances, including but not limited to off-site borrow and grading high walls, 5 acres or less.
12. Emergency filling and sealing pit subsidence in rural areas where historic properties are not effected.
13. Emergency filling and sealing pit subsidence projects in urban areas where the intent is to stabilize structures to ensure protection of property.
14. Shadow areas in which there will be no surface disturbance.

Dear Ms. Haaker:

Pursuant to the requirements of the State Agency Historic Resources Preservation Act and Section 106 of the National Historic Preservation Act of 1966, as amended, the Illinois Department of Natural Resources (IDNR) requests the following categorical exemption from conducting archaeological surveys. These actions will have no effect on known historic properties.

For all projects wherein IDNR is either the consultant for land-management plans regarding vegetation or a participant through action or monetary support in the actual clearing or planting of vegetation on private or public lands and where the project fits one or more of the following descriptions, IDNR recommends the project be given a categorical exemption from the requirement for conducting archaeological survey. The category of exemption will be referred to as Vegetation Improvement and does not apply where there are known human remains or known archaeological sites that are listed on the National Register of Historic Places, determined eligible for the Register, or determined potentially eligible for listing on the Register.

Description of projects meeting this exemption:

- Clearing, reseeding, or planting of woody or prairie vegetation on formerly cultivated ground as long as the action does not impact to the depth of previously undisturbed sediment.
- Clearing of vegetation in previously uncultivated pastures, wooded areas, or homesteads by hand or mechanical means on dry or frozen ground. Machinery must cause no subsurface impact nor disturbance of above ground structures or ruins.
- Clearing of vegetation by use of hand-held tools or mowing equipment that will have no subsurface impact with no restriction on ground conditions.
- Skidding of logs, except over known archaeological mounds, over marked burial plots, or through any cemetery.
- Burning of prairie or woodlands except where cemeteries are in danger of igniting.
- Planting of trees, saplings, or shrubs within an existing woods or pastures on forest or mixed-cover soils.

In accordance with the established procedures for coordination of Illinois Department of Natural Resources projects, IDNR requests the concurrence of the State Historic Preservation Officer in the determination that the projects described are exempt from the requirement for conducting archaeological surveys when no previously recognized significant or potentially significant historic property is involved.
