MEMORANDUM OF AGREEMENT AMONG CG PIKE CREEK LLC, THE ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, AND THE

ILLINOIS STATE HISTORIC PRESERVATION OFFICER REGARDING PIKE CREEK WIND FARM PROJECT, LOGAN COUNTY, ILLINOIS (SHPO LOG #006052121)

WHEREAS, CG Pike Creek LLC (Owner) plans to undertake the Pike Creek Wind Farm Project (Project)in Logan County, Illinois, in an area generally bounded by County Road (CR) 1250 North, CR 900 East, CR 600 North, and County Highway 15 (Attachment 1 – Project Location Map); and

WHEREAS, the Project requires a National Pollutant Discharge Elimination System (NPDES) permit from the Illinois Environmental Protection Agency (IEPA), thereby making the project an Undertaking subject to review under the Illinois State Agency Historic Resources Preservation Act (20 ILCS 3420) and its implementing rules (17 IAC 4180) (Act); and

WHEREAS, the Owner has consulted with the Illinois State Historic Preservation Office (SHPO), a Division of the Illinois Department of Natural Resources (IDNR), pursuant to the Act; and

WHEREAS, the State Historic Preservation Office (SHPO) currently resides within IDNR (Office), and the Director of IDNR is the duly designated State Historic Preservation Officer (Officer); and

WHEREAS, the Officer Determined that the eight (8) archaeological sites reported by the Owner in the Phase I Archaeological Survey reports completed for the project and submitted to the SHPO on November 9, 2023, and July 22, 2025, will not be adversely affected by the undertaking; and

WHEREAS, on January 19, 2024, the Officer determined that six properties within the Project's Area of Potential Effects (APE) are eligible to be listed on the National Register of Historic Places (NRHP), including the farmstead at 1037 300th Avenue, Middleton (Resource 60); a barn at 3034 300th Avenue, Middleton (Resource 63); a farmstead located along 900th Street (approximately 0.94-mile east of 275th Avenue), Middleton (Resource 94); the farmstead at 733 200th Avenue, Elkhart (Resource 130); the farmstead at 750 200th Avenue, Elkhart (Resource 132); and the dwelling at 238 700th Street, Elkhart (Resource 133); and

WHEREAS, the Officer has determined that the Undertaking will have an adverse visual effect on the properties that are eligible for the NRHP; and

WHEREAS, the public was notified of the Undertaking and given an opportunity to comment on the adverse effect in notices published in the *New Herald Times for Lincoln and Logan County*, the *Lincoln Daily News*, *The Pantagraph*, and the *Lincoln Courier* on June 20, 2025, with eight (8) comments received; and

WHEREAS, the Owner has notified seven (7) potential consulting parties of the adverse effect determination, and on June 12, 2025, the Elkhart Historical Society has chosen to participate in the consultation to resolve the adverse effect while the remaining six (6) potential consulting parties have chosen not to participate; and

NOW, THEREFORE, the Owner, IEPA, and the Officer agree that the Undertaking shall be implemented in accordance with the following stipulations in this Memorandum of Agreement (Agreement) in order to mitigate the adverse effects of this Undertaking to the NRHP-eligible properties.

STIPULATIONS

- I. MITIGATION (Study/Survey of Vernacular Residential Farmstead Types/Styles in Central Logan County, Illinois)
 - A. The Owner shall retain a historical contractor(s) of its choice (Contractor) who meets the Secretary of the Interior's Qualifications (36 CFR Part 61, https://www.nps.gov/history/local-law/arch_stnds_9.htm) to complete a study of vernacular architecture in central Logan County, Illinois. The study will include the townships comprising the APE for the Pike Creek Wind Farm Project. The Contractor shall:
 - 1. Upon execution of this MOA, the Owner will oversee development of a Research Design outlining the proposed methodology for the survey and the anticipated deliverable. The Research Design shall be approved by SHPO prior to initiation of field studies.
 - 2. Conduct archival research to establish representative vernacular types and stylistic influences for specific time periods as outlined in The Research Design.
 - 3. Conduct limited field surveys to document representative examples of the vernacular resource types identified.
 - 4. Attempt to identify particular builders or craftsmen involved in the construction of vernacular county farmhouses during the periods identified during the archival research.
 - 5. Prepare a report of the findings for review and use by SHPO. The report and associated spatial data for recorded resources will be submitted in hard copy and as a digital record that can be posted on the SHPO website. Within 30-days of receipt, the SHPO will advise in writing whether it concurs that the materials satisfy the mitigation requirements outlines in the MOA. If the SHPO does not concur it will explain why it does not concur.
 - 6. Project construction of the array, new location access roads, and other appurtenant features may commence upon execution of this document.

II. DURATION

This Agreement shall be effective until such time as all of its terms are satisfied or it is amended or terminated and replaced. Prior to such time, the Owner may consult with the other signatories to reconsider the terms of the Agreement and amend it in accordance with Stipulation VI AMENDMENTS below. The Owner shall notify the signatories as to the course of action it will pursue.

III. POST-REVIEW ENCOUNTERS

If previously unidentified historic (NRHP-listed or eligible) properties are encountered or if unanticipated effects to historic properties are identified, the Owner shall consult with the Officer immediately and make reasonable efforts to avoid, minimize, or mitigate adverse effects to such properties. In the event of an unanticipated encounter of human remains or burials, the Owner understands and agrees that it must immediately stop work within the area of encounter, consult with the Officer, and comply with the Human Remains Protection Act (20 ILCS 3440) and its implementing rules (17 IAC 4170) as administered by IDNR, which provides that no human remains shall be disturbed without a permit issued by IDNR. An Unanticipated Discovery Plan for the project is included as Attachment 2

IV. MONITORING AND REPORTING

Each year following the execution of this Agreement until it expires or is terminated, Owner shall provide all parties to this Agreement a summary report detailing work undertaken pursuant to its terms. Such report shall include any scheduling changes proposed, any problems encountered, and any disputes and objections received in Owner's efforts to carry out the terms of this Agreement.

V. DISPUTE RESOLUTION

Should any signatory to this Agreement object at any time to any actions proposed or the manner in which the terms of this Agreement are implemented, the Owner shall consult with the signatories to resolve the objection. If the signatories cannot agree regarding a dispute, the signatories shall utilize the procedures provided in 20 ILCS 3420/4e.

A. The Owner's responsibility to carry out all other actions subject to the terms of this Agreement that are not the subject of the dispute remain unchanged.

VI. AMENDMENTS

This Agreement may be amended when such an amendment is agreed to in writing by all signatories. The amendment will be effective on the date a copy is signed by all of the signatories.

VII. TERMINATION

If any signatory to this Agreement determines that its terms become impossible to carry out, that party shall immediately consult with the other signatories to attempt to develop an amendment per Stipulations V and VI above. If within thirty (30) days an amendment cannot be reached, any signatory may terminate the Agreement upon written notification to the other signatories.

VIII. COUNTERPARTS; FACSIMILE OR .PDF SIGNATURES

This Agreement may be executed in counterparts, each of which shall be considered an original and together shall be one and the same Agreement. A facsimile or .pdf copy of this Agreement and any signatures thereon will be considered for all purposes as an original.

EXECUTION of this Agreement by signatories, and the implementation of its terms evidence that the signatories have afforded the Officer an opportunity to comment on the effects of the Undertaking in compliance with the Act. Project construction may commence upon execution of this document.

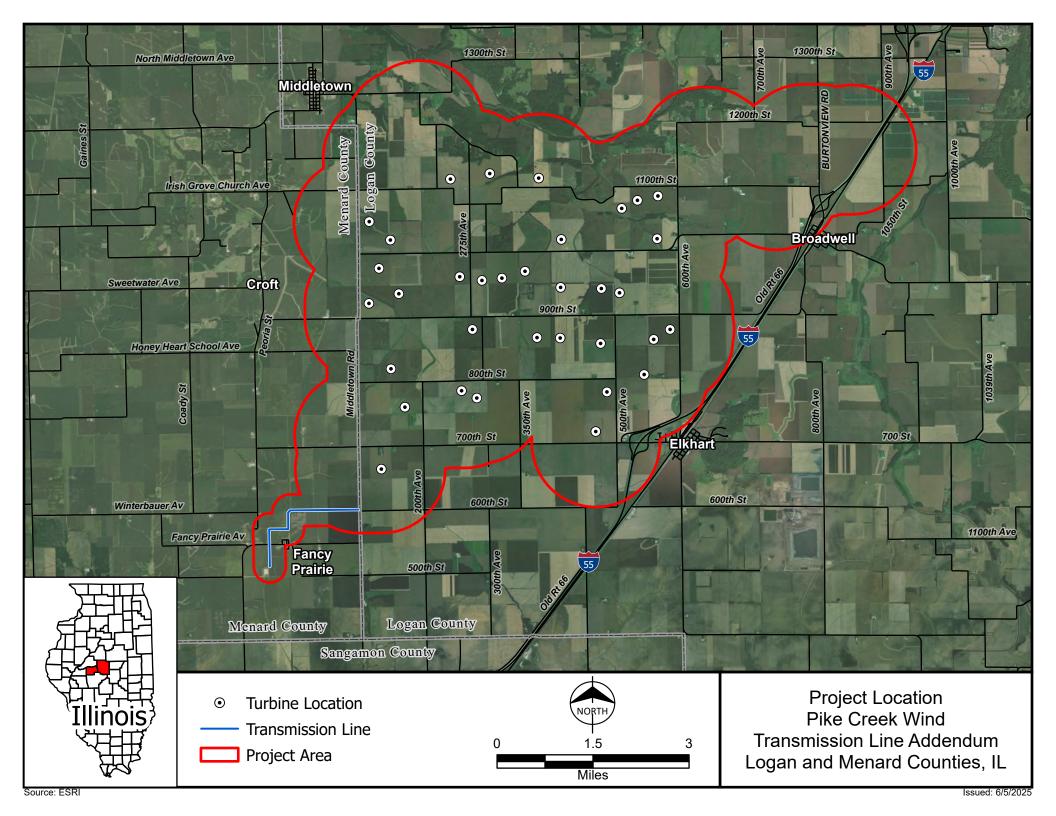

NOTICE TO THE PUBLIC OF HISTORIC PROPERTIES ADVERSE EFFECT

Six Historic-Age Properties located in the Communities of Middletown and Elkhart, Logan County, Illinois

CG Pike Creek LLC is proposing the construction of thirty-four (34) wind turbines, associated access roads, underground connection lines, a substation, an electrical generation intertie line, and other appurtenant facilities in an area encompassing approximately 6.6 miles east/west and 6.3 miles north/south in Logan County, Illinois (Project). Refer to the attached map depicting the proposed Project Location.

In accordance with the Illinois State Agency Historic Resources Preservation Act (20 ILCS 3420) and its implementing rules (17 IAC 4180) (Act), the Illinois State Historic Preservation Office determined the Project will have an adverse visual effect on six (6) historic-age properties that are listed or eligible for listing in the National Register of Historic Places (NRHP). The NRHP-eligible resources include the properties located at:

- 1037 300th Ave., Middletown
- 3034 300th Ave., Middletown
- 900th St. (approximately 0.94-mile east of 275th Ave., Middletown)
- 733 200th Ave., Elkhart
- 750 200th Ave., Elkhart
- 238 700th St., Elkhart

In order to resolve these adverse effects pursuant to the Act, CG Pike Creek LLC is seeking public input as potential mitigation options are developed to offset adverse effects to these resources. 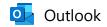

I recently came upon the request for public input regarding the proposed wind turbines of the CG Pike Creek LLC wind farm that would impact six historic sites located on the project map of Logan County in Illinois.

I am writing in strong opposition to the proposed installation of such large-scale wind turbines in our county. While I support responsible and sustainable energy solutions, this particular project comes at a significant cost to our rural landscape, historic preservation efforts, and already vulnerable local wildlife populations.

Erecting massive industrial turbines near these landmarks would irreparably damage their visual integrity. The towering structures would dominate the skyline, disrupting the pastoral landscape that has remained largely untouched for over a century - which cannot be said for the rest of Logan County that is already surrounded by wind and solar farms. These visual intrusions cannot be reversed and would forever alter the character of our treasured countryside. Turbines looming over preserved areas directly contradict the image that attracts visitors and supports small local businesses - something that Logan County depends on.

With your specialized background as a Conservator and Preservationist, I urge you to seriously consider the long-term visual, cultural, and biodiversity impact this project would have - not just on our county's view, but on its soul. Even though you do not live in our area, please treat it as you would your own. Progress should not come at the expense of beauty, history, and the irreplaceable natural life it supports. Please help us get these wind turbines moved away from such precious areas.

Thank you for your comment regarding the Adverse Effect for Six Historic-Age Properties located in the Communities of Middletown and Elkhart, Logan County, Illinois.

CG Pike Creek LLC has provided the following responses to your questions. Should you have any additional questions or comments please do not hesitate to reply.

- 1. Are there any plans after the end of life span like repowering the farm?

 **Answer: There are no current plans for repowering the wind farm after its useful life. Any changes to project plans would be made at a much later date and would be subject to any new or amended permits that would be required.
 - 2. Is there a plan and funds being set aside for reclamation? Who would be responsible for that project?

Answer: The project submitted a Decommissioning Plan as part of the Logan County permitting process. The Decommissioning Plan will be re-evaluated on the fifth anniversary of the Commercial Operation Date, and every 5 years thereafter at the Project's expense. The project also entered into an Agricultural Impact Mitigation Agreement with the Illinois Department of Agriculture, which requires the project to restore the land upon the end of the project life and remove project infrastructure. Along with the Decommissioning Plan, the County requires a financial assurance (bond or similar instrument) to address the costs of decommissioning and reclamation.

3. Can you tell me the country of origin of the parts being used in the building of the windmills?

Answer: The Turbine Supply Agreement has not been finalized for the project yet, and the country of origin for wind turbine components is unknown at this time. The parts for the turbines, towers, etc. could be supplied from multiple countries based on supply chain availability, tariffs and overall cost associated with the components.

4. Will there be a benefit to our community for lower power costs, or is this being used elsewhere?

Answer: The power generated by the project will be injected into the local high-voltage electrical transmission system, but it is unknown where the actual power will be distributed. A regional transmission operator will deploy the electricity where it is needed based on supply and demand on the broader transmission system. Power

generated by the project would be likely drawn first to the demand from local homes and businesses in the community to ensure that a refrigerator plugged into a wall or a lighting system for a commercial building actually turns on when needed. However, we cannot guarantee or have any ability to trace where the electricity is actually used by customers. Wind energy is one of the cheapest forms of energy generation because it has minimal ongoing operating costs, and it is not subject to fluctuating commodity costs in the same way that natural gas and coal used at fossil fuel generating plants are.

5. What is the general scope of impact that this project will have on the historical properties that will be in the way of this build?

Answer: No historic properties will be directly impacted by the project (all project turbines are located at least 0.25 mile from any of the identified historic properties). As determined by the State Historic Preservation Officer, the project would result in adverse visual effects that could affect six properties within the Project's Area of Potential Effects (APE) that are eligible to be listed on the National Register of Historic Places (NRHP), as described in the public notice:

- 1037 300th Ave., Middletown
- 3034 300th Ave., Middletown
- 900th St. (approximately 0.94-mile east of 275th Ave., Middletown)
- 733 200th Ave., Elkhart
- 750 200th Ave., Elkhart
- 238 700th St., Elkhart

6. Will there be any funds set aside to restore or maintain these properties if they are found to be of historical interest or relevance?

Answer: The project is in the process of entering into a Memorandum of Agreement (MOA) with the State Historic Preservation Office (SHPO), which will include stipulations the project will be required to undertake to address the adverse visual effects to NRHP-eligible historic properties. The mitigation stipulation in the MOA requires the project to fund and complete a study of vernacular architecture within the project's Area of Potential Effect (APE), providing meaningful mitigation for the identified adverse effects and contributing to the understanding of the region's architectural heritage.
