

**AMENDMENT No. 1 TO
MEMORANDUM OF AGREEMENT AMONG
DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY,
NORTH CENTRAL COLLEGE, AND THE
ILLINOIS STATE HISTORIC PRESERVATION OFFICER
REGARDING THE REPLACEMENT OF WINDOWS OF THE
OESTERLE LIBRARY IN NAPERVILLE, ILLINOIS

This Amendment (the "Amendment") to Memorandum of Agreement among the Department of Commerce and Economic Opportunity (DCEO), North Central College (the "Owner"), and the Illinois State Historic Preservation Officer (the "SHPO") (collectively, the "Parties") amends that certain Memorandum of Agreement (the "Original MOA"), made effective February 21, 2020, and signed by the Parties. The purpose of this Amendment is to extend the duration of the Original MOA for an additional eight (8) months from the expiration of the original agreement (from February 20 2022 to October 20 2022) utilizing the same terms and conditions of the Original MOA.

1. The Original MOA is amended as follows:

“II. Duration

This Agreement shall terminate if its stipulations are not carried out within two (2) years and eight (8) months from the date of its execution. Prior to such time, the Owner may consult with the other signatories to reconsider the terms of the Agreement and amend it in accordance with Stipulation VI AMENDMENTS below. The Owner shall notify the signatories as to the course of action it will pursue.”

2. All other terms and conditions under the Original MOA remain unchanged and in effect.

IN WITNESS WHEREOF, the Parties have hereunto caused this Amendment No. 1 to the Original MOA to be executed by their duly authorized representatives, effective as of the date of last signature.
