MEMORANDUM OF AGREEMENT BETWEEN SCOTT AIR FORCE BASE AND

THE ILLINOIS STATE HISTORIC PRESERVATION OFFICER
SUBMITTED TO THE ADVISORY COUNCIL ON HISTORIC PRESERVATION
PURSUANT TO 36 CFR SECTION 800.5(E)(4)
REGARDING THE RENOVATION OF GENERAL OFFICER QUARTERS #229

WHEREAS, the Commander, 375th Airlift Wing (AW), Scott Air Force Base (Scott) United States Air Force, proposes to renovate General Officer Quarters #229 (Renovation), and

WHEREAS, Scott has determined that the Renovation will have an adverse effect on General Officer Quarters #229 which is a contributing structure within the Scott Field Historic District, a district; which is eligible for listing on the National Register of Historic Places, and

WHEREAS, Scott has consulted with the Illinois State Historic Preservation Officer (SHPO) in accordance with Section 106 of the National Historic Preservation Act (NHPA) 16 U. S. C. Section 470, and its implementing regulations (36 CFR Part 800) to resolve the adverse effect of the Renovation of General Officer Quarters #229, and

NOW, THEREFORE, Scott and the SHPO agree that, upon acceptance of this MOA by the Advisory Council on Historic Preservation (Council) and upon Scott's decision to proceed with the Renovation, Scott shall ensure that the following stipulations are implemented in order to take into account the effect of the Renovation on historic properties.

STIPULATIONS

Scott shall ensure that the following stipulations are implemented:

1. Recordation

- a. Prior to the Renovation of General Officer Quarters #229, Scott shall contact the Historic American Buildings Survey/Historic American Engineering Record (HABS/HAER) to determine what level and kind of recordation is required for the property.
- b. Scott may award the recordation contract to a consultant of its choice, provided the consultant is qualified to perform the work and agrees to meet HABS/HAER Standards.

2. Renovation

- a. Scott shall provide 100 per cent design drawings for the Renovation of General Officer Quarters #229 to the SHPO for review and comment.
- b. The SHPO will complete review of the final design drawings and provide concurrence/nonconcurrence in writing to the Commander, 375 AW, Scott AFB IL.

Execution of the Memorandum of Agreement by Scott and the SHPO, its subsequent acceptance by the Council, and implementation of its terms evidence that Scott has afforded the Council an opportunity to comment on the Renovation of General Officer Quarters #229 and its effects on historic properties, and that Scott has taken into account the effects of the undertaking on historic properties.
