In accordance with Part IV (Monitoring and Reporting) of the Memorandum of Agreement (MOA) executed 9 September 2022, below (and attached) is a summary report of the work completed by the Forest Preserves of Cook County (FPCC) in accordance with the terms of the MOA.

## A Bridge to History

This small bridge not only lets a stream continue on its way—it's a piece of American history, as well. Built before WWII, the stone culvert is one of many picnic shelters, buildings and trail work projects throughout the Forest Preserves of Cook County created by the Civilian Conservation Corps.

President Franklin D. Roosevelt launched the CCC during the Great Depression to put men back to work across the country. In 1934, the CCC established Camp Deer Grove as a CCC site. The men lived and worked here, including at least one segregated African-American company. Their efforts included establishing a road system through the preserve on the path of existing dirt trails.

You can still see CCC structures in Deer Grove-West today, including several culverts on the western half of this trail and a spillway for the stream at the southern end of Deer Grove Lake.

### SIDEBAR

#### Deer Grove Through the Ages

Deer Grove is and has been Native American land for millennia. This area was an important place for the Potawatomi people before the U.S. imposed a series of treaties that transferred tribal land such as this to the federal government in the early 1800s.

In 1916, the Forest Preserves purchased 500 acres here from more than 100 landowners—the first forest preserve in Cook County. It is likely that a culvert over this stream was first built at that time, part of a landscaping project to create Deer Grove Lake.

Today, Deer Grove is nearly 2,000 acres, and Deer Grove West has been designated a Woodland and Wetland Nature Preserve, recognized as one of the highest quality natural areas in Illinois.
