## MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF ROCKFORD AND THE ILLINOIS STATE HISTORIC PRESERVATION OFFICER SUBMITTED TO THE ADVISORY COUNCIL ON HISTORIC PRESERVATION PURSUANT TO 36 CFR SECTION 800.5(e)(4) REGARDING 222 NORTH VALE AVENUE

WHEREAS, the City of Rockford, Illinois (the City) proposes to use Community Development Block Grant (CDBG) funds for the replacement of windows at 222 North Vale Avenue (the Property); and

WHEREAS, the City has determined that the project will have an adverse effect on the Property which is considered eligible for listing on the National Register of Historic Places; and

WHEREAS, the City has consulted with the Illinois State Historic Preservation Officer (SHPO) in accordance with Section 106 of the National Historic Preservation Act, 16 U.S.C Section 470 (NHPA), and its implementing regulations (36 CFR Part 800) to resolve the adverse effect of the project on historic properties; and

WHEREAS, it has been decided that it would not be in the public interest to go forward with direct in kind window replacement and has been decided in consultation with the SHPO to install white vinyl sliders with white internal grid;

NOW, THEREFORE, the City and the SHPO agree that, upon acceptance of this MOA by the Advisory Council on Historic Preservation (Council), and upon the City's implementation of the project, the City has afforded the Council an opportunity to comment on the project and its effects on historic properties, and that the City has taken into account the effects of the project on historic properties.
